TERMINATION OF MEMBERSHIP

7 (a) A member may resign from the association at any time by giving notice in writing to the Secretary. Such resignation shall take effect at the time such notice is received by the Secretary unless a later date is specified in the notice when it shall take effect on that later date.

(b) If a member –

is convicted of an indictable offence; or fails to comply with any of the provisions of the Rules; or has membership fees in arrears for a period of two months or more; or conducts himself/herself in a manner considered to be injurious or prejudicial to the character or interests of the Association, the Management Committee shall consider whether his/her membership shall be terminated.
